

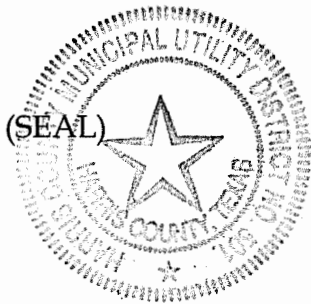
NOTICE OF MEETING

HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 501

21. Approve pay estimates, change orders and/or final acceptance for construction contracts, including for the following construction projects:
- a. water, sewer, drainage and paving facilities to serve Towne Lake Towne Lake, Section 37;
 - b. water, sewer, drainage and paving facilities to serve Towne Lake, Section 32, partial replat No. 1;
 - c. water, sewer, and drainage facilities to serve Towne Lake, Section 15 partial re-plat no. 1 and Section 15 partial re-plat no. 2; and
 - d. clearing and grubbing for Towne Lake, Section 41.
22. Update on bond application no. 3.
23. Requests for capacity reservation to Harris County Municipal Utility District No. 500 (Master) and requests for utility commitments.
