
HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 501

The Board of Directors of Harris County Municipal Utility District No. 501 will hold a regular meeting on **Wednesday, November 2, 2016, at 12:30 p.m.**, at the offices of **Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, Rio Grande Conference Room, Houston, Texas**, to discuss and, if appropriate, act upon the following items:

1. Approve minutes.
2. In-District meetings.
3. Town Hall meeting.
4. Financial and bookkeeping matters, including payment of the bills and review of investments.
5. Unlimited Tax Bonds, Series 2016:
 - a. appoint Paying Agent/Registrar and Escrow Agent;
 - b. approve Preliminary Official Statement and Official Notice of Sale;
 - c. disclosures pursuant to Municipal Securities Rulemaking Board requirements; and
 - d. authorize advertisement for sale of the Series 2016 Bonds and schedule bond sale.
6. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
7. Conduct public hearing regarding District's tax rate, adopt Order Levying Taxes, and authorize execution of Amendment to Information Form.
8. Garbage collection and recycling.
9. Website matters.
10. Operation of District facilities, billings, repairs and maintenance.
11. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
12. Engineering matters.
13. Approve Submerged Storm Sewer Agreements.
14. Approve plans and specifications and authorize advertisement for bids, and review bids and award construction contracts, including for the following projects:
 - a. water, sewer, and drainage facilities to serve Towne Lake, Section 44; and
 - b. water, sewer, and drainage facilities to serve Towne Lake, Section 41.
15. Approve pay estimates, change orders and/or final acceptance for construction contracts, including for the following construction projects:
 - a. water, sewer, drainage and paving facilities to serve Towne Lake Towne Lake, Section 37;

- b. water, sewer, and drainage facilities to serve Towne Lake, Section 15 partial re-plat no. 1 and Section 15 partial re-plat no. 2; and
 - c. clearing and grubbing for Towne Lake, Section 41.
16. Update on bond application no. 3.
 17. Requests for capacity reservation to Harris County Municipal Utility District No. 500 (Master) and requests for utility commitments.
 18. Approve contract with Storm Water Solutions, L.P.
 19. Accept or grant conveyance of deeds, utility deeds, and easements and approve consents to encroachment, encroachment agreements, rights of entry, and abandonment of easement.
 20. West Harris County Regional Water Authority ("WHCRWA"), including surface water conversion.
 21. Report regarding development in the District.
 22. Report from District consultants regarding District correspondence and provision of records.
