
HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 501

The Board of Directors of Harris County Municipal Utility District No. 501 will hold a regular meeting on **Wednesday, April 5, 2017, at 11:00 a.m.**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, Rio Grande Conference Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. In-District meetings, and discuss public comment structure.
4. Financial and bookkeeping matters, including payment of the bills and review of investments.
5. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
6. Garbage collection and recycling, including shred event.
7. Website matters.
8. Operation of District facilities, billings and convenience fees, repairs and maintenance, including:
 - a. Resolution Approving Treasury Management Services; and
 - b. Request from Harris County Emergency Services District No. 9 regarding insurance service organization review.
9. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
10. Conduct annual review and receive report from operator on Identity Theft Prevention Program and adopt Identity Theft Prevention Program Amendment.
11. Approve Consumer Confidence Report and authorize operator to mail Consumer Confidence Report and file certificate of mailing with the Texas Commission on Environmental Quality.
12. Approve annual report on implementation of Water Conservation Plan.
13. Conduct Annual Review of Drought Contingency Plan.
14. Engineering matters, including report on grade separation at Union Pacific Railroad and intersection improvements at Highway 290.
15. Approve Submerged Storm Sewer Agreements.
16. Approve plans and specifications and authorize advertisement for bids, and review bids and award construction contracts, including for the following projects:
 - a. water, sewer, and drainage facilities to serve Towne Lake, Section 44; and
 - b. water, sewer, and drainage facilities to serve Towne Lake, Section 41.

17. Approve pay estimates, change orders and/or final acceptance for construction contracts, including for the following construction projects:
 - a. water, sewer, drainage and paving facilities to serve Towne Lake, Section 37; and
 - b. clearing and grubbing for Towne Lake, Section 41.
18. Requests for capacity reservation to Harris County Municipal Utility District No. 500 (Master) and requests for utility commitments.
19. Approve contract with Storm Water Solutions, L.P.
20. Accept or grant conveyance of deeds, utility deeds, and easements and approve consents to encroachment, encroachment agreements, rights of entry, and abandonment of easement.
21. West Harris County Regional Water Authority ("WHCRWA"), including surface water conversion.
22. Report regarding development in the District.
23. Report from District consultants regarding District correspondence and provision of records.
24. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, to conduct a private consultation with attorney to discuss pending or contemplated litigation, or a settlement offer.
25. Reconvene in Open Session and authorize appropriate action regarding contemplated litigation, or a settlement offer.
