

NOTICE OF MEETING

 - b. water, sewer, and drainage facilities to serve Towne Lake, Section 39, Replat 1.
13. Approve pay estimates, change orders and/or final acceptance for construction contracts, including for the following construction project:
 - a. water, sewer, and drainage facilities to serve Towne Lake, Section 44.
14. Water, sewer, and drainage facilities and paving repairs in Towne Lake, Section 27.
15. Requests for capacity reservation to Harris County Municipal Utility District No. 500 (Master) and requests for utility commitments.
16. Approve contract with Storm Water Solutions, L.P.
17. Accept or grant conveyance of deeds, utility deeds, and easements and approve consents to encroachment, encroachment agreements, rights of entry, abandonment of easement, and environmental proposals.
18. West Harris County Regional Water Authority matters.
19. Report regarding development in the District, including acquisition of new tract within the District.
20. Discuss Master District recreational and detention facilities.
