

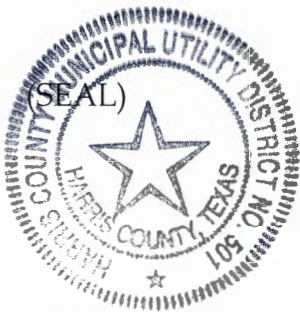
NOTICE OF MEETING


HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 501

The Board of Directors of Harris County Municipal Utility District No. 501 will hold a regular meeting on **Wednesday, March 6, 2019, at 5:30 p.m.**, at **The Lakehouse, 10000 Towne Lake Parkway, Cypress, Texas**, to discuss and, if appropriate, act upon the following items:

1. Receive public comments.*
2. Approve minutes.
3. Authorize auditor to conduct audit for fiscal year end March 31, 2019.
4. Financial and bookkeeping matters, including payment of the bills and review of investments.
5. Adopt budget for fiscal year end March 31, 2020.
6. Order Adopting Amended and Restated Procedures for Continuing Disclosure Compliance.
7. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
8. Adopt Resolution Concerning Exemptions from Taxation.
9. Discuss garbage collection and recycling matters, including report from Trash Committee, update on spring community shred event, and garbage services contract.
10. Website matters.
11. Operation of District facilities, billings and convenience fees, repairs and maintenance.
12. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
13. Review Water Conservation Plan; approve annual report and water conservation implementation report on implementation of Water Conservation Plan; and adopt Order adopting Amended and Restated Water Conservation Plan.
14. Review Drought Contingency Plan; and adopt Order Adopting Amended and Restated Drought Contingency Plan.
15. Engineering matters, including report on grade separation at Union Pacific Railroad and intersection improvements at Highway 290.
16. Approve Submerged Storm Sewer Agreements.
17. Authorize design, approve plans and specifications, authorize advertisement for bids, and review bids and award construction contracts, including for the following projects:

 - a. water, sewer, and drainage facilities to serve Towne Lake, Section 39, Replat 1; and

- b. water, sewer, and drainage facilities to serve Towne Lake, Section 41.
19. Water, sewer, and drainage facilities and paving repairs in Towne Lake, Sections 27 and 28.
20. Water, sewer, and drainage facilities and paving repairs in Towne Lake, Section 37.
21. Requests for capacity reservation to Harris County Municipal Utility District No. 500 (Master) and requests for utility commitments.
22. Approve contract with Storm Water Solutions, L.P.
23. Accept or grant conveyance of deeds, utility deeds, and easements and approve consents to encroachment, encroachment agreements, rights of entry, abandonment of easement, and environmental proposals.
24. West Harris County Regional Water Authority matters.
25. Report regarding development in the District, including acquisition of new tract within the District.
26. Approve legal conflicts waiver.
27. Approve Fourth Amendment to Contract for Financing, Operation, and Maintenance of Regional Facilities.
